**PETITIONERS' UNOPPOSED MOTION FOR EXTENSION OF TIME  
TO FILE RESPONSE TO RESPONDENTS' MOTION FOR REHEARING**

Petitioners, the Florida Engle Class, pursuant to Fla.R.Civ.P. 9.300(a) move for an unopposed seven (7) day extension of time to file their response to the motions for rehearing and/or clarification of all Respondents, and as grounds therefore state:

WHEREFORE, Petitioners most respectfully request that this Court grant

Petitioners a seven (7) day extension of time to file their response to Respondents' motions for rehearing and/or clarification, to and including September 13, 2006.


